1. Definitions

- **“Works”**: All photographs, video footage, audio recordings, reporting, graphics, data, or other content supplied by Acme News under this Agreement.
- **“Original Use”**: The specific story, edition, article, or broadcast segment identified above.
- **“License Term”**: Perpetual, but limited to the Original Use.
- **“Outlet”**: The specific publication, channel, or platform named above in the Territory listed on Licensee’s News Outlet Registration Form.

2. Grant of License

Acme News grants Licensee a **non-exclusive, perpetual, non-transferable license** to use the Works **once**, solely in the Original Use and solely in the Outlet and Territory specified.

- **Print** – In one identified edition/run of Licensee’s publication.
- **Web / Digital** – In one identified article or page on Licensee’s website or app.
- **Broadcast** – In one identified program segment produced by Licensee.

Any new use — including re-runs, new editions, different outlets, or use outside the Territory — requires a separate license.

3. Editorial Use Only

Unless separately negotiated, Works are licensed **strictly for editorial use** in news reporting, commentary, or educational content. Commercial, promotional, or advertising use is prohibited.

4. Restrictions

Licensee may not:

- Reuse Works in new stories, editions, or broadcasts.
- Transfer, sublicense, or share Works with affiliates, partner outlets, or syndication networks.
- Alter Works beyond minor cropping/resizing for layout.
- Remove or obscure credits, metadata, or watermarks.
- Use Works outside the Territory specified.
- Remove IPTC and/or Copyright metadata

5. Credit & Attribution

Licensee must provide visible credit:

- **Print & Web** – “[Photographer/Author Name] / Acme News.” or for archived content “[Acme News Archive].
- **Broadcast** – On-screen or verbal acknowledgment at least once per segment.

Photos will contain IPTC and Copyright metadata. Failure to properly credit is a breach and may incur additional fees.

6. Archival Rights

License is **perpetual for the Original Use**. Works may remain in:

- Print archives, bound editions, or microfilm copies of that edition.
- Web archives of the licensed article.
- Station archives or on-demand platforms for the licensed broadcast segment.

Archival use is limited to the Original Use only. Reuse in future editorial content requires a new license.

7. Compensation

- License is valid only upon full payment of fees and invoices.
- Fees are based on media type, scope of Original Use, and outlet size.
- Taxes and duties are Licensee's responsibility.

8. Termination

- Acme News may terminate for breach with thirty (30) days' notice if uncured.
- Upon termination, Works must be removed from active circulation within sixty (60) days.
- Archival rights remain valid unless revoked due to breach.

9. Remedies

Unauthorized use (outside the Original Use, outlet, or territory) may result in fees up to **200% of the original license cost**, plus attorney's fees and injunctive relief.

10. Specimens

Licensee agrees to provide Acme News with:

-
- A PDF or physical copy of the print edition.
 - A working link to the web article.
 - A digital copy of the broadcast segment.

Acme News may use these specimens for portfolio, awards, or promotional purposes.

11. Indemnification & Liability

- **Licensee** indemnifies Acme News against claims arising from misuse, defamation, or third-party rights issues.
- **Licensor** warrants ownership/control of Works. No model/property/trademark releases are provided unless expressly noted.
- **Limitation of Liability:** Acme News' liability is capped at the total license fee paid.

12. Governing Law & Venue

This Agreement is governed by the laws of the **State of Wyoming**. Any disputes shall be resolved exclusively in the state or federal courts located in **Randolph County, North Carolina**. Prevailing party may recover attorney's fees and costs.

13. Entire Agreement

This Agreement is the complete understanding between the parties. Amendments must be in writing. Electronic signatures are binding.
